In addition, I agree to pay Warm World an annual administrative fee of fifty dollars (\$50) for one child. Families with two children will pay a total of \$75, and three or more children families will pay a total of \$100. I will also pay Warm World my scheduled weekly tuition in full on Monday morning of each week, or the first day my child attends the Center that week, or as indicated on my Simply Giving Form according to the tuition fee schedule in the Warm World Tuition Policy Statement.

I agree to pay a late charge of \$5.00 if Warm World has not received the tuition payment in full by my weekly due date. I understand that interest will be charged on my account at the maximum rate allowed by the Fair Credit Act if my account becomes past due seven (7) days. I understand if tuition remains unpaid in full for over 14 days, my children are subject to immediate termination from the Center. I agree to pay all reasonable collection fees including attorney and court costs. Warm World has the right to update and/or change the terms of this Child Care Services Agreement upon thirty (30) days written notice.
